



PRIVACY POLICY - KNOW YOUR RIGHTS



The Belgian Air Force Spotting Group is **NOT COLLECTING ANY PERSONAL DATA** if you just visiting our website! **We don't use tracking cookies! We don't use van Google Analytics to follow your behavior on our website.**

We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a survey or provide feedback on any of our message boards or via email.

BAF Spotting group vzw collects your data so that we can:

- Process your order and manage your account.
- Email you our newsletters
- We will NOT share your data with other organizations or company's so that they may offer you their products and services.

BAF Spotting group vzw securely stores your data at our administration systems for the period you are a member of our organization. When a member leaves our organization his/her personal information will be deleted from our administration systems. For one-time customers we don't store any data; after the processing time of your order your personal information will be deleted.

MARKETING

We don't send any marketing information to random people. We only communicate with our members and one-time customers concerning their membership.

What are your data protection rights?

BAF Spotting Group vzw would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Our Association for copies of your personal data. We don't charge for this service.

The right to rectification – You have the right to request that Our Association correct any information you believe is inaccurate. You also have the right to request to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Our Association erase your personal data.

The right to restrict processing – You have the right to request that Our Association restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Our Association processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Our Association transfer the data that we have collected to another organization, or directly to you, under certain conditions.
